

1.1 Rental Contract. The Radio Dealer agrees that he or she has rented the items listed on the accompanying invoice and upon the express condition that it will at all times remain the property of the Lessor (rf Services). These policies stated herein, along with the invoice, credit information, credit card authorization and other documents are all part of the same rental contract.

1.2 Rental Period. Daily rentals are for 24 hours. Weekly rentals are for seven consecutive days and monthly rentals are for 30 consecutive days. The minimum rental period we will accommodate is 5 days.

Rental period begins when the equipment leaves the Radio Dealer's premises and ends when returned to the Radio Dealer. Liability for all equipment begins at the start of the rental period.

A late fee of 1% of the total rental cost will be charged for each hour the equipment is retained beyond the expiration of the rental period. Overtime of six or more hours shall be charged at the full, one-day, per radio rate.

Equipment is charged on a time-out (24 hour) basis whether it is in use or not.

1.3 Time of Return. Time is the essence of this contract since the radios may be promised to others. Extensions must be approved at least 24-hours in advance of the expiration date.

Equipment is expected to be shipped back to rf Services within 24 hours of the expiration date of the rental. The Radio Dealer will pay the freight charges to ship the equipment back to rf Services.

- **1.4 Rental Rates.** Rates are specified on the last page of this contract as well as the invoice that ships with the rental order. The rental rates listed on this contract do not include delivery or pick up charges, fuel, applicable taxes, cleaning or repair charges, assessments or any other incidental costs or expenses. All such charges will be paid by the Lessee.
- **1.5 Delivery.** The Radio Dealer will pay the freight charges to ship the rental order to the Radio Dealer. Pickup or delivery charges to the Lessee must be added (if applicable) by the Radio Dealer.

Damage to any equipment upon pick up by the Radio Dealer is the responsibility of the Lessee. The Radio Dealer shall be acting as the Lessee's agent in transporting any such property and all risks for loss or damage shall remain the Lessee's responsibility.

- **1.6 Insurance.** Certificates of insurance are not considered security for the equipment rented. The Lessee is solely responsible for all charges directly to rf Services. Lessor (rf Services) will enforce its remedies directly against the Lessee without resort to its insurance company. To this end, an imprint of a major credit card is required.
- **1.7 Credit Card Guarantee.** The Radio Dealer agrees, requests and authorizes Lessor (rf Services) to charge the credit card provided for any of the following charges:
- * Replacement cost of any equipment not returned by the due date.
- * Charges which have not been paid within 30 days of invoice date including repairs or replacement of any equipment which is lost, damaged or stolen.
- **1.8 Liability.** Lessor (rf Services) is in no way responsible for any liability, claims, costs or expenses arising from the use or possession of this equipment. All parties using the equipment are subject to FCC rules and regulations as well as local and state ordinances. If the equipment leased under this contract is not used in the manner in which it was designed, rf Services is not responsible for any damages, injury or other occurrences caused by this equipment.
- **1.9 Cancellation.** Any order canceled 24 hours or less before the start of the rental period will be charged at 50 percent of the total order.
- **2.0 Inoperable equipment.** Lessor's (rf Services) equipment is inspected and tested at the time of rental. Lessor (rf Services) must be notified within 24 hours if any equipment fails to operate. Unless notified, Lessor (rf Services) will consider all equipment, regardless of its actual condition, to be on rental. Please return inoperable equipment to the Lessor (rf Services) immediately for evaluation. The Lessor (rf Services) will make a reasonable effort to repair or replace the equipment in the shortest amount of time.
- **2.1 Payment.** Radio Dealers who do not have pre-approved open credit terms with rf Services shall pre-pay the total cost of the rental with a credit card. The Radio Dealer must also provide a valid credit card to cover loss, damage and repairs prior to equipment leaving Lessor's (rf Services) warehouse.

Radio Dealers with an open account will be billed as normal (NET 30).

2.2 Return of Equipment. The Lessor (rf Services) is not responsible for shipping delays once the equipment is picked up by the carrier. All rental fees shall remain in accordance to section 1.2 of this contract.

2.3 Replacement or Repair. Upon return of damaged equipment, Lessor (rf Services) will make a determination of the extent of damage and required repairs. In determining whether equipment shall be replaced or repaired, the judgment of Lessor (rf Services) shall be conclusive.

Should Lessor (rf Services) determine that the equipment shall be replaced, Lessee shall be responsible for the cost to replace the same item or the closest comparably-equipped model, at the Radio Dealer's current price level with rf Services without deduction for depreciation.

Damage includes any type of damage by fire or water; attempts to make repairs by the Lessee or anyone else other than rf Services or the Radio Dealer; installation of parts or accessories, product modification or failure to follow instructions contained in the operator's manual is also considered damage.

Lessor (rf Services) disclaims any liability for range and coverage.

Rental will be charged at full price on damaged equipment until repair or replacement has occurred to the satisfaction of Lessor (rf Services).

- **2.4 Serial Numbers.** The serial numbers of the equipment rented will be listed on the invoice to the Radio Dealer. The Radio Dealer shall pay the current reseller cost to replace any equipment which has had the serial numbers removed or altered.
- **2.5 Lost, stolen or destroyed equipment.** In the event that, after delivery to Lessee, any of the equipment is lost, stolen, damaged beyond repair, destroyed or otherwise disappears or is not returned, the Radio Dealer will be responsible for the cost to replace the same item or the next comparably-equipped item at current reseller price without deduction for depreciation. Rental will be charged at full price on such equipment until it is paid for.
- **2.6 Theft.** In all instances, immediately report any missing, lost or stolen equipment to Lessor (rf Services).
- **2.7 Purchase Price.** Rental payments may not be applied to the repair cost, replacement cost or purchase price of any equipment. If the lessee wishes to purchase the equipment delivered for rental, the Radio Dealer will be quoted and charged the normal reseller price for the items rented.
- **2.8 Local use only.** Equipment is rented under the stipulation that it is to be used in the geographic area of sales and service coverage of the Radio Dealer unless otherwise specified in writing.
- **2.9 Violation of Laws.** Lessee shall not permit the equipment to be used in violation of any laws or applicable regulations.
- **3.0 Sublease.** The Lessee may not sublease any part of the equipment without written consent from the Lessor (rf Services).

- **3.1 No Warranty or Guarantee**. The equipment rented is provided without warranty or guarantee of any kind.
- **3.2 Radio Programming / Frequency Use.** The Radio Dealer will be responsible for programming radios or supplying rf Services with the frequencies to be used by the Lessee. The responsibility of FCC coordination and the use of proper frequencies and power levels will be that of the Radio Dealer.
- **3.3 Applicable Laws.** This contract shall be deemed to have been made in Paulding County Georgia and shall be interpreted in accordance with the laws of the State or Georgia.
- **3.4 Authorized Representative.** The person signing this contract certifies that they have read the contract and the policies; that they are duly authorized to sign such an agreement for the company or entity they represent; and that the execution of this document has been authorized by all necessary officers or owners of the business or entity.
- **3.5 Foreign Use.** The equipment rented is not to be used outside the USA. The Lessee must have the written permission of rf Services to use any equipment outside the USA.
- **3.6 Attorney's Fees.** If necessary to enforce collection of the amount due under this contract, the Radio Dealer agrees to pay all collection costs and charges including court costs and attorney's fees plus service or finance charges of 1.5% per month on all balances 30 days or more delinquent.
